The insufficiency of paradigms does not prevent the derivation of the inflectional suffix in mn.; the number of nouns of the 2nd type in the 3rd person of the verb and in the degrees of comparison of adjectives and, therefore, does not prevent their conversion ratio with single-root words, but prevents the isolation of the inflectional suffix in the singular, since to solve such issues it is necessary to take into account the entire language system, and not just individual cases. In English, in addition to the two known types of conversion (the type when the paradigms of words differ in their categories).

Abstract. On the example of an empirical study of foreign students and Russian cadets of the Moscow State University of the Ministry of Internal Affairs of Russia named after V.Ya. Kikot' studied the possibility of including the concept of humanity in the category of mentality. By pairwise comparison of humanity in interpersonal and intergroup relations of students from Vietnam (20 people), Tajikistan (20 people), Mongolia (20 people), the peculiarities of ideas about humanity that arise during joint learning are revealed. The measurements were carried out using the author's methodology "Humanity-dominance". To determine the differences in the indicators of humanity as a structural element of the national mentality, groups of Russian cadets of 22 people were introduced into the empirical sample. The total sample was 82 people. The use of one-way analysis of variance (Anova) revealed differences at $p < 0.01$ for the descriptors infatuation ($F = 315.424$) and dominance ($F = 315.424$). The results can be used to select study groups and prevent destructive conflicts.
